### Supplier information upon harmful substances in apparel

European and national legislations have increasingly enacted laws and regulations to protect consumer health. This includes regulations about harmful substances in apparel. Both importers and retailers are obligated due to their liability to examine whether these regulations are considered.

The most relevant substances are:

Forbidden cancerogenic Azo-dyestuffs (prohibited by German Dutch and Austrian legislation as well as EU-legislation Supplement to 76/769/EEC); testing methods according to LMBG B 82.02. -2 -3 and -4).

Nickel release in metal trim in direct and prolonged contact with the skin (restricted by Directive 94/27/EC; testing method EN 1811 combined with EN 12472).

Pentachlorophenol (restricted to 5 ppm by German Chemical Act; Testing method according

LMBG B 82.02.-8).

Cadmium (restriction by European legislation for cadmium pigments in plastic and surface coatings to 100 ppm; supplement to 76/769/EEC 91/338/EEC; test method EN 1122). Sensitizing Dispense Dyes (prohibited according §30 German Foods and Commodities Law). Chromium VI (prohibited according §30 German Foods and Commodities Law; testing method DIN 53314).

Chlorinated organic carriers (prohibited according §30 German Foods and Commodities Law). Tin-organic compounds / TBT (prohibited according §30 German Foods and Commodities Law).

Beyond that further restrictions as per EU- or national laws might be relevant for certain products:

Certain Flame retardants (TRIS PBB TEPA etc.) according to EU-legislation supplement to annex of 76/769/EES 79/663/EEC and 83/264/EEC.

Phthalates in plastic according European Union legislation 1999/815/EEC.

Certain pesticides such as DDT DDD DDE Lindan etc...

All mentioned substances have been subjects of legal regulations or generally accepted recommendations (such as Tox-Proof-Label or Oekotex-Standard 100). We strongly recommend that all suppliers and their sub-suppliers ensure that articles meet the limits as per Oekotex-Standard 100. (Please see: www.oeko-tex.com)

We herewith inform you that we will continue and intensify our own testing on delivered garments. Every item that fails to meet the mentioned limits and might cause harm to customers' health will be taken out of warehouse and returned to the supplier.

The packing list must include the following information:

- Supplier's name
- Importer's name
- Invoice reference
- Shipping mark
- Order number
- Article number

- Description of goods
- Carton number
- Size assortment / breakdown per carton
- Summary / breakdown
- Measurement / carton
- Cbm.
- Gross weight
- Net weight
- Total number of cartons

Original E/L has to be send by courier on/before shipping of goods.

# **Packing instruction for cartons**

Lots: Lots must be packed as assortments only. No different colours in same carton. Cartons must be clearly marked as per shipping marks.

Poly bags: Each garment must be flat packed in poly bag full covered. Zipper heads / buttons must be wrapped in paper and placed properly in order prevent marks in garments. Hangtag to be placed in plastic pocket.

Packaging: Packing of cartons shall be filled to the top. Cartons must be solidly closed with tape and strengthened with strap band. Inside each carton must be placed small silicon bags.

End Cartons: Should it be impossible to pack the whole order into the right assortments all cartons with deviations be considered as end cartons. The number of end carton has to be a minimum. Cartons packed as end cartons have to be marked separately with specific information of the content and must be marked with a visible red marking tape.

### **Packing instruction for hanging garments**

Lots: Hanging garment in one lot must be linked together with an elastic band or set seal.

Poly bags: Hanging garment must be packed separate in sealed poly bag on hanger fully covered.

Assortments: Lots have to be packed in assortments as described in the order. The assortment must be marked with:

- Assortment type
- Order number
- Article no.
- Colour code
- Style name
- Size/pcs.
